- **About Savitribai Phule Pune University, Pune**

It is one of the premier universities in India, is positioned in the North-western part of Pune city. It occupies an area of about 411 acres. It was established on 10th February, 1949 under the Poona University Act. The university houses 46 academic departments. It is popularly known as the 'Oxford of the East'. It has about 307 recognized research institutes and 612 affiliated colleges offering graduate and under-graduate courses.

Moreover, it holds approvals from the Pharmacy Council of India (PCI) and University Grants Commission (UGC) under Sections 2(f) and 12(b) of New Delhi. Offering a range of Pharmacy courses including D. Pharmacy, B. Pharmacy, M. Pharmacy, and Ph.D., the college also provides value-added certificate courses (D. Voc.) in DRA and IPR under NSQF level-5, approved by UGC and affiliated with Savitribai Phule Pune University, Pune. Notably, its B. Pharmacy (Grant-in-Aid) course is re-accredited by the National Board of Accreditation (NBA) for the period of June 2022 up to June 2025, and the college has secured a position in the NIRF band 102-125. The college has recently initiated a patent filing facility known as Pradnya.
